- one filled-in application for granting a fixed-period residence permit (plus 3 copies) including a reason for a residence within the territory of the Republic of Poland for a period longer than 3 months;
- four-colour, undamaged 4.5 cm x 3.5 cm photographs, taken within 6 months, taken against a bright uniform background, of good definition, clearly showing the eyes and the face from the top of the head to the upper part of the shoulders, so as the face occupies 70-80% of the photograph. The photographs should present the person without a hat or glasses with dark lenses, looking straight, the eyes opened and not covered with the hair, the face with natural expression and the mouth closed.
- a valid travel document (plus 4 copies of all filled-in pages);
- four copies of a valid residence card;
- a valid certificate of temporary residence (plus 1 copy);
- a certificate from an institution documenting enrolment for studies or continuation of studies, stating the period of studies determined in the regulations, a proof of payments made if required by an institution in order to undertake or continue studies;
- health insurance as understood by the regulations on health care services financed from public funds or a certificate documenting that an insurance company shall cover medical treatment costs within the territory of the Republic of Poland;
- documents stating that the applicant is in possession of sufficient financial means to cover the costs of maintenance and return travel! and shall not need to use social/assistance;
- documents stating that the applicant is in possession of sufficient financial means to cover the costs of studies;
- a certificate from a competent Revenue Office in Poland of no tax arrears or amount of overdue tax or not being registered as a tax payers;
- a birth certificate.

The fee for issuing a fixed-period residence permit is 340,00 PLN.
